Q. 1. How are political parties recognised as regional and national parties in India? Explain with examples.

[CBSE Delhi, Set 1, 2019]

Ans. Democracies that follow a federal system all over the world tend to have two kinds of political parties. Parties that are pres-

ent in only one of the federal units and parties that are present in several or all units of the national level. Every party in the country has to register with the Election Commission. Parties that get a unique symbol and some other special facilities are 'recognized' by the Election Commission for this purpose. That is why these parties are called, 'recognized political parties'. A party that secures at least six percent of the total votes in an election to the Legislative Assembly of a State and wins at least two seats is recognized as a 'State Party.' For example – Trinamool Congress, Shiv sena, DMK etc. A party that secures at least six percent of the total votes in Lok Sabha elections or Assembly elections in four states and wins at least four seats in the Lok Sabha is recognized as a 'National party.' For example, BJP, Indian National Congress.

Q. 2. Explain the three components of 'political party.' [CBSE Delhi, Set 2, 2019]

- Ans. (i) Leader: A leader is the one who takes the major decisions of the party and his decision is the supreme command for the party. He contests elections and performs the administrative job.
 - (ii) Active Members: Another component of political party are the active members who contest elections for the party and are elected as representatives. They are the ones, who climb the ladder from being the follower and become the assistants of the leaders to gain knowledge about the politics.
 - (iii) Followers: The last one are the followers who support a political party and in elections make their party victorious. They are simply the ardent followers of the leaders and work under the able guidance of the active members.

Q. 3. Explain any three functions of opposition political parties.

Ans. The Opposition's main role is to question the government of the day and hold them accountable to the public. In legislature, the Opposition Party has a major role and must act to discourage the party in power from acting against the interests of the country and the common man. They hustle to present themselves as a suitable alternative government.

Following are the three functions of opposition parties:

- (i) They question the ruling government and make them accountable to the public.
- (ii) Their role is to ensure that the government should not take any step which is against the interest of the public.
- (iii) Their duty is to check and ensure that the action of the ruling party is for the benefit of the masses and to support the government in such things. They, thus, facilitate formation of public opinion and are a way in which the schemes of government are checked and communicated to the public.

Q. 4. Analyse the role of opposition political parties in democracy.

Ans. Opposition political parties play an important role in democracy. They play both positive and negative roles.

Positive Role:

- (i) They ensure that political party, in power does not, abuse or misuse its power.
- (ii) It exposes the weaknesses of ruling party.
- (iii) It keeps a close vigil on the bills and expenditure of government.

Negative Role:

- (i) It targets the government and aims at lodging and discrediting the government for all the ills and troubles that people face.
- (ii) Through stalling the proceedings of the parliament, dharnas and gheravs, it curtails the progress of the country.
- (iii) Sometimes, opposition party opposes es every decision of the ruling party whether it is in the favour of the nation or not.

- Ans. Regional Political Party exists, operates and functions at the regional level. It gives prominence to regional issues, specific problems of the region and it has influence only on the people of that region. It lays more stress on regional culture identity,

which it wants to preserve and promote. Conditions required to be recognised as a regional political party are:

- (i) It should have polled at least 6% valid votes in an election to the Legislative Assembly.
- (ii) It has reached in at least three states in last general election.
- (iii) It had won at least two seats in Legislative Assembly elections.

Ans. The reasons for the necessity of the political parties in India are given below:

- (i) Modern democracies cannot exist without political parties. The necessity of a political party in democracy can be understood from the given points.
 - If every elected representative is independent, and then no one can make promise for any major policy changes. The government may be formed but its utility will remain always uncertain. Non-party based Panchayat election also creates same problems.
- (ii) The rise of political parties is directly linked to the emergence of representative democracies. As society became larger and complicated, they also need some agency to gather dif-

- ferent views on various issues and to present these to the government.
- (iii) Political parties inform the people about the working of the ruling party. They discuss the problems of the state, the working and failure of the government and give suggestion for the upliftment of masses.
- **(iv)** Political party acts as a link between government and masses.
- (v) Political parties form and run governments. The executive body is formed by people from the ruling party. Various political leaders are assigned different ministries to carry out the task of governance.

- **Ans.** The following efforts have been made to reform political parties in India:
 - (i) Supreme Court has helped in reducing the influence of criminals and money in elections. It is now mandatory for every person contesting the election to give an affidavit regarding his wealth and criminal cases pending against him. With this peo-

- ple can acquire information about their leaders and this has also led to decline in criminalisation of politics.
- (ii) These days no one can change his/her party after Anti Defection law was passed in the Parliament. Amendment was made in the constitution to prevent MPs and MLAs from changing parties. If anyone tries to change his/her party, he/she loses his/her seat.
- (iii) Election Commission has also ordered all political parties to hold their organisational elections and file the income tax returns for the purpose of introducing internal democracy. Parties have started to do so formally.
- (iv) Regulating internal affairs in the party should be made compulsory. Registers of the existing members should be made. All parties should follow their constitution and regular elections should be held for the higher post of the party.
- (v) State should provide funds for contesting elections. It can be either given in the form of cash or in the form of petrol, paper, telephone, etc. This may reduce the influence of money in the elections.

Ans. Political party is an organised group of people having common ideology and its aim is to contest elections and come to power.

Four characteristics of political parties are given below:

- (i) Political parties seek control over the government through the process of election.
- (ii) Parties run the government. They ensure that a country is governed as per set ideologies.
- (iii) Parties frame their own policies in the form of manifestos which includes their vision on the basis of which they would establish governance in the country.
- (iv) Political parties make laws and policies for the country. Members of the legislature belongs to various political parties and are guided by party ideologies.
- (v) Parties give representation to diverse interest in society and give recognition to minorities.
- (vi) A political party has a leader, active members and followers who support the party.

Q. 6. Explain any five functions of the ruling party. [CBSE OD, Set 2, 2019]

Ans. Functions of Ruling Party are follows:

- (i) A ruling party is one which has anchored dominant part in elections and has framed the legislature. Ruling party guarantees that the nation keeps running according to set belief systems and projects.
- (ii) Ruling Party offers portrayal to different enthusiasm for society, they offer acknowledgment to minorities and give access to individuals to government machinery. The nationals can likewise vent their complaints to nearby local party leaders regarding any arrangement and its execution.
- (iii) Party in the power reassures and makes individuals mindful about its welfare plans, it encourages individuals to think about its accomplishments, its plan and profit and its advantages.
- **(iv)** It establishes foreign relations and decide the foreign policy of the country. Thus, the future and the reputation of the country is upheld by them.
- (v) Ruling Party organises schemes and campaigns for the welfare of the

people. It makes schemes for the development of society both culturally and economically.

Ans. Functions of Political Parties:

- (i) Candidates are put forward by political parties to contest elections. These candidates may be chosen by the top leaders or by members of the party. In some countries like USA, members and supporters of a party choose its candidate.
- (ii) Parties put forward their policies and programmes for voters to choose from them. A government is expected to base its policies on the line taken by the ruling party (Political party then runs government).
- (iii) Political parties play a major role in making laws for the country. No law can become a bill unless majority parties support it.
- (iv) Political parties provide people access to government machinery and welfare schemes. It is easy for the public to approach their local party leader than a government officer. The local party leader has to listen to the public demand, otherwise people can reject them in the next elections.
- (v) Parties shape public opinion. They raise and highlight issues. Parties sometimes also launch movements

for the resolution of the problem faced by the people.

- Q. 9. "It is very difficult to reform politics through legal ways." Evaluate the statement. [CBSE OD, Term 2, Set 1, 2017]
- Ans. We agree that it is very difficult to reform politics through legal ways. It is very tempting to think of legal ways of reforming politics, to think of new laws to ban undesirable things, but this temptation needs to be resisted. No doubt, law has an important role to play in political reform. Carefully devised changes in law can help discourage wrong political practices and encourage good ones. But legal constitutional changes by themselves cannot overcome challenges to democracy. This is like the rule of cricket. A change in rules for LBW decisions helped to reduce negative batting tactics. But the improvement is possible mainly by combined efforts by the players, coaches and administrators. Similarly, democratic reforms are to be carried out mainly by political activists, parties, movements and politically conscious citizens.
- Q. 10. Suggest any five effective measures to reform political parties.

- **Ans.** Following are the five effective measures to reform political parties:
 - (i) A law should be made to regulate the internal affairs of political parties.
 - (ii) It should be made compulsory for political parties to maintain a register of its members.
 - (iii) It should be made mandatory for political parties to give a minimum number of tickets (about 1/3rd) to its woman candidates.
 - (iv) There should be a quota for woman in the decision making bodies of the parties.
 - (v) The government should give parties money to support their election expenses in kind, for example petrol, paper, phone bill, etc.
- Q. 11. "No party system is ideal for all countries and in all situations." Analyse the statement.

- **Ans.** 'No party system is ideal for all countries and in all situations'. This statement can be justified as follows:
 - (i) All countries and democracies have different social situations, economic achievements and culture and thus different political situations leading to different party systems.
 - (ii) Party system is not anything that a country can choose. It evolves gradually and slowly depending on the situations in the country.
 - (iii) Party system depends on the country's social and regional differences, its history of politics and elections system.
 - (iv) India has evolved a multiparty system because its regional and geographical differences are not easily absolved by even two parties.
 - (v) But not all countries have such diversity and so may not need multiparty systems. In such countries, a two party system may be enough for the representation of various communities. Thus, no party system is ideal for all countries and in all situations.
- Q. 12. Analyse the main functions of 'Political Parties.'

[CBSE Delhi, Term 2, Set 2, 2017, 2015]

- **Ans.** 'Political Parties' perform the following functions in a democracy:
 - (i) Parties contest elections: In most of the democratic countries, elections are fought mainly among the candidates put up by the political parties. Parties select their candidates in different ways in India. Top party leaders choose candidates for contesting elections.
 - (ii) Parties put forward different policies and programmes: Each one may have different opinion and views on what policies are suitable for society. In democracy, large number of similar opinions are grouped together to provide a direction in which policies can be formulated by the government. Making these policies is the function of political parties. The government is expected to make its policies on the time taken by the ruling party.
 - (iii) Parties make laws for the country: Though laws are passed by the legislature but since most of the members belong to a party, they go by the direction of party leadership, irrespective of their personal opinions.
 - **(iv)** Parties form and run government: Political parties recruit leaders, train them and make them ministers to run the government in the way they want.
 - (v) Parties play role of the opposition to the parties in power: They voice different views and criticise government for its failures or wrong policies. Opposition parties also mobilise opposition to the government.
 - (vi) Parties shape public opinion: They shape public opinion by raising and highlighting issues. They do these through pressure groups, which are the extensions of political parties and also launch movements for resolutions of problems faced by the people.
 - (vii) Parties provide people access to government welfare schemes: For an ordinary citizen, it is easier to approach a local party leader than a government officer. They feel close to party even if they do not fully trust them.

Even parties have to be responsive to the people's needs and demands otherwise people can reject the parties in next elections.

Q. 13. Examine the main 'challenges' before 'political parties.'

[CBSE Delhi, Term 2, Set 3, 2017]

- **Ans.** The major challenges posed before political parties are as follows:
 - (i) Lack of internal democracy: ordinary members do not get sufficient information about what it going on within the party. The leader has greater power and tend to rule the party.
 - (ii) Dynastic succession: Generally, members of a family tend to rule the party. Eg: Nehru (Gandhi) family rule the congress party.
 - (iii) Money and muscle power: As parties are only interested in winning power they nominate those candidates who have or can raise a lot of money such as Rich people, businessmen and criminals.
 - (iv) They do not offer meaningful choice to the voters as many parties are different in their policies and ideologies. Sometimes, people cannot even elect different leaders as same set of leaders keep changing their parties.
 - (v) Casteism and religion in politics by parties: When one religion is pitted against another, by the political parties, this is called communalism or communal politics. Some parties or politicians promote the cause of the majority religious group at the cost of minorities. This produces a dangerous trend of majority tyranny.

- **Ans.** Political parties are necessary for democracy due to the following reasons:
 - (i) They provide voters with alternative ways of governance and economic management on which the voters can exercise choice.
 - (ii) They provide candidates in elections who, if victorious, go to the legislature to make laws.

- (iii) They provide the leaders who form the government to run the administration.
- **(iv)** They also form the opposition in the legislature to act as a check on the government.
- (v) These parties provide a means for the general people to make their voices heard in the legislature and government. They represent the people in the legislature and ensure that laws are passed to reflect the will of the general people.
